

The above financial upgradation is subject to the following conditions:

- 1 There will be no change in the designation or the nature of duty is performed. The status of the employee remains unchanged.
- 2 The financial upgradation under MACP scheme is purely personal to them and shall have no relevance for their seniority position i.e. they will not confer any seniority benefit.
- 3 Grant of higher grade pay under the MACP scheme shall be conditional to the fact that the employee while accepting the said benefits shall be deemed to have given acceptance for regular promotion on occurrence of vacancy subsequently.
- 4 The financial upgradation entitles the employee concerned to avail certain benefits which is linked to the pay drawn by the employee.
