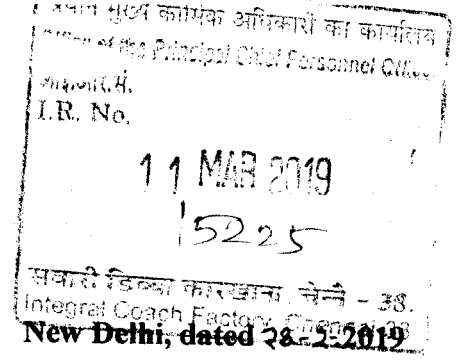

CIRCULAR

Sub: Filling up the the Group 'B' Gazetted ex cadre post of OSD/TP/Railway Board in Pay Band 2 Grade ₹ 9300-34800/- plus Grade Pay ₹ 4800/- (pre-revised).

It is proposed to fill up the Group 'B' /Gazetted/ex-cadre post of OSD/Transport Planning, Railway Board in Pay Band-2 Grade ₹ 9300-34800/- plus Grade Pay ₹ 4800/- on deputation basis. Officers of the Indian Railways (including Railway Board) possessing the following service conditions & educational qualifications are eligible for being considered for the post :-

(a)	(i)	Holding analogous posts on regular basis; or
	(ii)	With 3 years' regular service in Pay Band-2 ₹ 9300-34800 plus Grade Pay ₹ 4600; or equivalent or
	(iii)	With 8 years' regular service in Pay Band-2 ₹ 9300-34800 plus Grade Pay ₹ 4200; or equivalent
(b)	Educational qualifications and experience:	
	(i)	Degree from a recognized University or equivalent
	(ii)	Five year's working experience in Operating/Planning Department.
	(iii)	Good knowledge of MS Word, Excel and Power Point to analyze the freight data and generate various reports as required;
	(iv)	Good command over English and able to draft notes, letters etc: and
	(v)	Knowledge of Railway network and new developments taking place in Railways.
	(vi)	Previous working experience in Railway Board and Inter-Ministerial liaison will be desirable.

Note: Period of deputation including the period of deputation in another ex-cadre post held preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.


2. The crucial date for determining the educational qualification/other eligibility conditions shall be the closing date for receipt of applications from the candidates. It may be brought to the notice of the candidates applying for the post that they shall not be allowed to withdraw their candidature subsequently under any circumstances.

3. The applicants who have applied earlier in response to Circulars of even number dated 01.09.2017 and 25.09.2018 are required to submit their applications afresh, if they so desire.

Applications received after the said due date and without proper channel/requisite documents would summarily be rejected.**
