**CIRCULAR**

Sub:- Revision of tariff of ICF Marriage Halls.

Ref:- Circulars of even No. dated 06/11/2012, 01/12/2016,

29/04/2017, 26/08/2017, 07/12/2017, 27/2/2018 & 17/9/2018

The tariffs of the ICF Thiruvalluvar Marriage Hall is revised and the security deposit rates for serving employees of ICF are reduced for ICF Thiruvalluvar, Kambar & Tholkappiar Halls with effect from 24/1/2019 as under:

The revised tariff includes rent, developmental charges, cleaning charges, maintenance, LED strip light charges(for Kambar/Tholkappiar Halls), Lighting, LED Video, Guest rooms(for Thiruvalluvar Hall) security deposit and GST @ 18% on the entire tariff. On completion of function, GST will be levied on actual usage charges and security deposit after deductions and balance GST will be refunded to the Marriage Hall allottees. All allottees who henceforth book the three ICF Marriage Halls will be required to pay the Marriage Hall charges as detailed above. For those allottees of Thiruvalluvar Marriage Hall who have already booked the Hall/paid the charges upto 23/1/2019, the additional charges levied for Lighting, LED Video and Guest Rooms will be deducted from the security deposit refundable to the allottees. Booking of Marriage Halls for outsiders will be from 11<sup>th</sup> day of the month after drawal of lots /allotment for serving/retired railway employees on 10<sup>th</sup> of every month.

All other terms and conditions will remain the same. The above has the approval of Competent Authority.
